Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

**C1.1.5** - Driving in a manner incompatible with general safety or departing from the standard of a reasonably competent driver.

#### Reason for the decision:

Numerous occurances of Contact with the rear of Car 19 during the race. This is despite being told at Snetterton that this style of driving would not be tolerated.

Data from Cars 19 and 57 has been examined by Porsche Technical and claims of being "brake tested" are unfounded. E-mail report to support this attached.

Note that in accordance with Championship Regulation 4.2.3 (A) this penalty also carries a two championship point deduction and two category point deduction.

#### Brands investigation

Laps 5 onwards, TSL says there is only a small gap between cars 19 and 57

By overlaying car 19 against itself we can observe for unusual patterns in throttle, brakes or gear selected, and the data doesn't show anything other than normal driver variance which occurs between laps anyway

By overlaying car 57 against itself we can observe for unusual patterns in throttle, brakes or gear selected, and the data doesn't show anything other than normal driver variance which occurs between laps anyway

The pi data doesn't show anything out of the ordinary, and therefore can't support a driving standards investigation.

For driving standards investigations the VBOX video is more useful as any "issue" can be seen in real time, with the attendant driver inputs of throttle, steering, and brakes all (usually) visible and also available explicitly in data channels.
