Report from marshals post 7 of contact between Car 80 and Car 43 with both cars leaving the circuit. Drivers interviewed and footage reviewed from Car 43. Drivers and onboard footage confirmed no contact was made. Both drivers agreed no further action is required. Car 80 had no onboard footage, driver reminded that series regulation 2.13(iv) applies and has to fix before next race.
