The Stewards heard evidence from the following persons:

NATHAN EDWARDS. PAUL MANNING - DRIVER OF CAR #46. ON-BOARD FOOTAGE FROM BOTH CARS AND FROM CAR #10 FOLLOWING BEHIND WAS VIEWED.

MIKE RITCHIE (ENTRANT OF NATHAN EDWARDS) WAS PRESENT BUT DID NOT PRESENT EVIDENCE. LUKE CAUDLE WAS PRESENT TO PLAY THE ON-BOARD FOOTAGE BUT DID NOT PRESENT EVIDENCE.

The Stewards decision is:

TO HEAR THE APPEAL ALTHOUGH IT WAS RECEIVED OUT OF TIME AS IT HAS BEEN ESTABLISHED THAT THIS WAS DUE TO LACK OF AVAILABLE INTERNET ACCESS.

THE APPEAL FAILS. THE DECISION OF THE CLERK OF THE COURSE TO PENALISE THE COMPETITOR FOR A BREACH OF GR Q.12.21.4 IS UPHELD.

Reason(s) for this decision:

THERE WERE TWO CONTACT INCIDENTS BOTH CLEARLY VISIBLE IN THE FOOTAGE AND NOT DISPUTED BY EITHER PARTY.

NATHAN EDWARDS ADMITTED TO CAUSING THE FIRST CONTACT.

IT IS THE OPINION OF THE STEWARDS THAT CAR #21 DID NOT HAVE A SUFFICIENT OVERLAP ON CAR #46 IN THE SECOND CONTACT TO ALLOW THE MANOEUVRE TO BE COMPLETED. THEREFORE NATHAN EDWARDS IS PREDOMINANTLY TO BLAME FOR CAUSING THE COLLISION.

THE STEWARDS DEEM THAT THE PENALTY APPLIED BY THE CLERK OF THE COURSE IS APPROPRIATE IN THESE CIRCUMSTANCES.
