The Stewards heard evidence from the following persons:

IAN AGUILERA. PHIL GLEW (P/G OF DRIVER). ON-BOARD FOOTAGE FROM CAR 77 WAS VIEWED FROM EXITING THE PIT LANE UNTIL AFTER THE INCIDENT AT CLARKS (TURN 6).

AN EVENT SAFEGUARDING OFFICER WAS NOT AVAILABLE TO ATTEND THIS HEARING.

The Stewards decision is:

THE APPEAL FAILS. THE DECISION OF THE CLERK OF THE COURSE TO PENALISE THE COMPETITOR FOR A BREACH OF Q12.24.3 IS UPHELD.

Reason(s) for this decision:

AFTER EXITING THE PIT LANE, THE DRIVER PASSED A MINIMUM OF FOUR (4) LIGHT PANELS THAT WERE DISPLAYING FLASHING YELLOW WITH SC. THE DRIVER ACKNOWLEDGED THAT HIS ON-BOARD SIGNALLING LIGHT WAS ALSO FLASHING.

IT IS THE OPINION OF THE STEWARDS THAT THE DRIVER DID NOT SLOW DOWN SUFFICIENTLY TO ENSURE THAT FULL CONTROL OF HIS VEHICLE WAS RETAINED. THIS RESULTED IN HIM RUNNING WIDE WITH PART OF HIS CAR IN THE GRAVEL WHILST MARSHALS WERE ATTENDING AN INCIDENT.

THE STEWARDS CONSIDER THE PENALTY IMPOSED BY THE CLERK OF THE COURSE TO BE APPROPRIATE AND IS IN ACCORDANCE WITH THE GUIDELINE PENALTY SET DOWN BY MOTORSPORT UK FOR THIS OFFENCE.
