## Reason(s) for this decision:

The Stewards referred to General Regulations Section B, Nomenclature and considered that Century Motorsport was:

- 1. Not the party involved in the incident which gave rise to the decision to apply a five second penalty for violation of track limits
- 2. Car #57 (entrant is Century Motorsport) did not lodge a protest which resulted in the decision.
- 3. Car #57 (entrant is Century Motorsport) is not the party against whom a penalty has been imposed.
