DOMINIC STOTT - ENTRANT HITECH GP. NOAH LISLE - DRIVER CAR 14 AND HIS P/G AND ENTRANT, STEPHEN HUNTER. THE DRIVER OF CAR 16 (EDUARDO COSETENG) HAD ALREADY LEFT THE CIRCUIT.

ITV EXTERNAL FOOTAGE AND ON-BOARD FOOTAGE FROM CARS 14, 16 AND 63 (FOLLOWING CAR) WAS VIEWED.

AN EVENT SAFEGUARDING OFFICER WAS NOT AVAILABLE TO ATTEND THIS HEARING.

The Stewards decision is:

THE APPEAL FAILS. THE DECISION OF THE CLERK OF THE COURSE TO PENALISE THE COMPETITOR FOR A BREACH OF Q12.21.4 IS UPHELD.

Reason(s) for this decision:

HAVING VIEWED THE EVIDENCE PRESENTED TO THEM, THE STEWARDS ACKNOWLEDGE THAT THERE WAS MINOR CONTACT BETWEEN CARS 14 AND 16 BUT ARE NOT PERSUADED THAT CAR 14 PUSHED CAR 16 OFF THE TRACK. THE STEWARDS ARE CLEAR THAT CAR 16 LEFT THE TRACK AT THE CHICANE AND IN REJOINING MADE CONTACT WITH CAR 14. THE STEWARDS FIND THAT THE DRIVER OF CAR 16 IS RESPONSIBLE FOR CAUSING THE SUBSEQUENT COLLISION WITH CAR 14 AND THAT THE PENALTY IMPOSED BY THE CLERK OF THE COURSE IS APPROPRIATE.
