The Stewards heard evidence from the following persons:

RICKY COLLARD (DRIVER CAR 21) AND ENTRANT, CHRISTIAN DICK. TOM INGRAM (DRIVER CAR 80) AND ENTRANT MARVIN HUMPHRIES. EXTERNAL ITV FOOTAGE AND ON-BOARD FOOTAGE FROM BOTH CARS WAS VIEWED.

The Stewards decision is:

THE APPEAL FAILS. THE DECISION OF THE CLERK OF THE COURSE TO PENALISE THE COMPETITOR FOR A BREACH OF C2.3 IS UPHELD.

Reason(s) for this decision:

THE STEWARDS NOTE THAT TOM INGRAM HAD JUST COMPLETED AN OVERTAKE ON RICKY COLLARD AND WAS ENTITLED TO DEFEND HIS POSITION INTO THE FOLLOWING CORNER AND THAT RICKY COLLARD HAD NOT GAINED ANY SIGNIFICANT OVERLAP. THE STEWARDS ARE NOT PERSUADED THAT TOM INGRAM MADE AN UNDUE CHANGE OF DIRECTION AND ARE SATISFIED THAT AN UNFAIR ADVANTAGE WAS GAINED BY RICKY COLLARD AS A RESULT OF CONTACT MADE. THE STEWARDS FURTHER FIND THAT THE PENALTY IMPOSED BY THE CLERK OF THE COURSE IS APPROPRIATE TO THE CIRCUMSTANCES.
