## The Stewards decision is:

The Appeal is upheld and the Stewards further decide that the 3-grid place penalty applied to Oliver Gray #63 is set aside and replaced by the addition of a 3-second Time Penalty added to his elapsed race time. 3 penalty points are to be recorded on Oliver Gray's Competition Licence as a result of this decision

Reason(s) for this decision:

The Stewards, having considered video and verbal evidence from both drivers and team managers support the view that a grid place penalty is inappropriate in this situation and have agreed that the most appropriate penalty is the addition of a time penalty to be added to the elapsed race time for Car #63.
