Liam McNeilly #48, Karl Goshawk Fox Motorsport Team Manager and Guardian On-board video footage from car #48

The Stewards decision is:

Race / Class:

The Appeal succeeds in that the driver of car#48 admits liability for causing the collision. However the Stewards consider that a Formal Written Reprimand (2 Points to be recorded on his licence) is a more appropriate penalty and the 5 grid-place penalty is set aside.

Reason(s) for this decision:

The Stewards, having heard from both the driver and Team Manager and having reviewed the on-board footage believe that there are mitigating circumstances in that an incident occurred immediately prior to car #48 entering Brooklands (Turn 4). This may have affected the track conditions in the braking area. The Stewards accept that this caused #48 to lose an element of control and he made contact with the rear of #21.
