Jack Mitchell, driver of Car #19 accepted responsibility for the contact with Car #315 exiting Turn 4.

The Stewards decide that as a result of the contact he inadvertently gained an unfair advantage and therefore the decision of the Clerk of Course is upheld and the Stewards deem that the penalty imposed is appropriate.
