The Appeal Fails. The Stewards support the decision of the Clerk of Course to penalise Jack Bartholomew for making contact with rear of Car #2 at Turn 2 on Lap 1 of Porsche Race 1.

## Reason(s) for this decision:

The evidence reviewed by the Stewards was not conclusive in proving that there was contact between Car #59 and Car #89, causing #89 to make contact with Car#2 (causing #2 to spin). The Stewards therefore uphold the decision of the Clerk of Course and decide that the penalty applied is appropriate.
