The Stewards heard evidence from the following persons:

Jason Lockwood #315, Andy Menzies (Excelr8 Motorsport). Timekeepers log analysis for Quaife Mini Challenge Race 1 also examined.

The Stewards decision is:

The Appeal is supported and Car #315 should be re-instated in the results of Quaife Mini Challenge Race 1, as per general regulations (Q12.24.4) following the showing of a Red Flag where the leader has completed 75% of the scheduled race distance.

Reason(s) for this decision:

The Stewards are satisfied that Car #315 entered the pits under it's own power, with a punctured wheel which was replaced and #315 intended to rejoin the race. The competitor noted that the Red Flag had been displayed during this pit-stop and therefore was unable to leave the pits (Timekeepers data indicated that #315 entered pits at 14.09.53.731 and the Red Flag was displayed at 14.10.38.404 - a difference of 44.673 seconds allowing time to change the wheel and be ready to rejoin the race). For this reason the Stewards consider that Car #315 was still able to proceed in the race at the time of showing of the Red Flag. Car #315 should be classified as a finisher in the results of Quaife Mini Challenge Race 1.
