Following investigations, I find that you are guilty of contravening the following Motorsport UK Regulation(s):

Q12.21.4 Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car

**Brief Details:**

#70 caused a collision with #23 at Turn 7 on lap 11, resulting in #23 spinning

Accordingly, under Motorsport UK Regulation G 5.3, I hereby order that you receive the following:

Verbal Warning

Additional Comments: #70 explained that he had attempted to overtake #23 approaching Turn 7, but that he was unable to slow the car sufficiently and ran wide in the corner which allowed #23 to 'cut-back' behind him and draw alongside on the exit of the corner where the lines of the two cars converged. #70 had attempted to avoid the collision and onboard footage confirms that in running wide, the left hand wheels of car #70 ran beyond the edge of the kerb which unsettled the car causing the collision. The Clerk of the Course accepts that no malice was intended and that the driver of Car #70 attempted to avoid the collision, and therefore determines that a Warning is appropriate in this instance.

You are reminded of your right of appeal. Any penalties applied will be recorded by Motorsport UK in accordance with Motorsport UK Regulation C 2.1.4
