DRIVER 6 JOHN POWELL.

The Stewards decision is:

TO FINE JOHN POWELL THE DRIVER 6, £500 AND YOUR LICENCE BE ENDORSED WITH 3 PENALTY POINTS.

Reason(s) for this decision:

AFTER HEARING FROM DRIVER 6 JOHN POWELL AND VIEWING ON BOARD FOOTAGE FROM TRUCK 5, WE COULD SEE DRIVER 6 JOHN POWELL URINATING UP THE FRONT WHEEL/TYRE OF TRUCK 6. THEREFORE WE FIND YOU GUILTY OF THE FOLLOING:

(H 6) Bring the sport into disrepute.

(C 1.1.8. Misbehaviour or unfair practice)

(C 1.1.4. Any proceeding and/or act prejudicial to the interest of the ASN and/or motor sport generally.)

2.1.5. Penalty points will be imposed for the following offences:

(iii) General Conduct – Abuse, physical assault or threats of physical assault. Refusal to obey the instructions of an Official

2.1.7. The number of points will be determined not by reference to the type of offence but by reference to the type of penalty imposed.

(iii) Fine, Time, Grid Place or Position/lap penalty – 3 points

C/R 1.6.3 If a Competitor receives licence Penalty Points in accordance with Motorsport UK regulation C 2.1.5 to C 2.1.7, points of the same value as the Penalty Points will be deducted from the Competitors Championship points total.

So there will be a deduction of 3 Championship Points.
