Following investigations, I find that you are guilty of contravening the following Motorsport UK Regulation(s):

Q12.21.4 Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car

Brief Details:

#27 caused a collision with Cars #1 and #65 at Turn 1 with subsequent contact at Turn 2 on lap 1, resulting in Cars #1 and #27 retiring with damage

Accordingly, under Motorsport UK Regulation G 5.3, I hereby order that you receive the following:

Formal Reprimand (2 Points) Number of Licence Penalty Points: 2

Additional Comments: #27 made a poor start allowing both Cars #1 and #65 to move ahead, with #65 on the left, fully ahead of #27 and #1 on the right slightly ahead of #27 as the cars approached Turn 1. Onboard footage shows car #27 braking later than cars #65 and #1 resulting in #27 moving into the closing gap between cars #65 and #1 as all 3 cars turned into the corner, which resulted in a collision between all 3 cars. The Clerk of the Course finds the driver of car #27 wholly to blame for causing the collision having failed to allow for the presence of the other two cars when braking for the first corner on lap 1 of the race. In determining the penalty the Clerk of the Course notes the drivers relative lack of experience as this is only his 2nd event, that he was starting in the class pole position due to the reverse grid format, and that he failed to finish the race as a result of this incident, so determines that a Formal Reprimand with 2 licence penalty points is appropriate in this instance

You are reminded of your right of appeal. Any penalties applied will be recorded by Motorsport UK in accordance with Motorsport UK Regulation C 2.1.4
