The Stewards heard evidence from the following persons:

ADAM SMALLEY AND HIS ENTRANT, BARRY HORNE. ROBERT DE HAAN (#46) AND HIS ENTRANT, ANDY RICHARDSON. SAM OAKLEY WAS PRESENT TO PLAY FOOTAGE FROM THE TWO INCIDENTS FROM CAR #21, CAR #46 AND CAR #5 (CAR FOLLOWING).

The Stewards decision is:

THE APPEAL SUCCEEDS. THERE WERE TWO SEPARATE INCIDENTS - ONE ON LAP 1 AND ONE ON LAP 3. THE STEWARDS DEEM THEREFORE THEY SHOULD BE TREATED AS TWO SEPARATE INCIDENTS EACH WITH THEIR OWN DECISION.

FOR THE INCIDENT ON LAP 1 AT KNICKERBROOK, THE DRIVER OF CAR #46, ROBERT DE HAAN, IS FOUND GUILTY OF CONTRAVENING MOTORSPORT UK REGULATION Q12.21.4 AND IS GIVEN A FORMAL WRITTEN REPRIMAND [2 POINTS] WHICH ALSO CARRIES A 2 CHAMPIONSHIP POINT AND 2 CATEGORY POINT DEDUCTION.

FOR THE INCIDENT ON LAP 3 AT ISLAND HAIRPIN, THE DRIVER OF CAR #46, ROBERT DE HAAN, IS FOUND GUILTY OF CONTRAVENING MOTORSPORT UK REGULATION Q12.21.4 AND IS GIVEN A FORMAL WRITTEN REPRIMAND [2 POINTS] WHICH ALSO CARRIES A 2 CHAMPIONSHIP POINT AND 2 CATEGORY POINT DEDUCTION.

Reason(s) for this decision:

LAP 1 INCIDENT AT KNICKERBROOK. THE STEWARDS FIND THAT THE DRIVER OF CAR #46 WAS PREDOMINANTLY RESPONSIBLE FOR CAUSING THE COLLISION WITH CAR #21.

LAP 3 INCIDENT AT ISLAND HAIRPIN. THE STEWARDS FIND THAT THE DRIVER OF CAR #46 WAS PREDOMINANTLY RESPONSIBLE FOR CAUSING THE COLLISION WITH CAR #21 AND AS A RESULT GAINED A POSITION.
