The Stewards decision is:

that the actions of Mr Bob Moffat constitute an offence as defined by General Regulation C.1. 1. 9. Mr Moffat does not hold a licence issued by Motorsport UK but it is accepted that he is a member of the One Motorsport with Starline Racing team.

That team is accordingly fined the sum of Two thousand five hundred pounds (£2,500.)

Reason(s) for this decision:

The evidence is that Mr Bob Moffat was walking in the pitlane and was outside the pit garage allocated to One Motorsport with Starline Racing. A member of that team, a mechanic, Loasby,drew Moffat's attention to a team car coming into the box. Moffat took exception to the way this was done, pushed the mechanic backwards and placed his hand on the mechanic's throat.

The team manager, Morgan, then intervened, separated the two of them with the result that, according to the team manager, Moffat grabbed him by the shirt and pulled him toward him.

The team owner, Williams, then intervened and attempted to defuse the situation.

The mother of one of the teams driver's, Mrs Chilton then appeared and asked Moffat to leave. This resulted in a verbal altercation between herself and Moffat in the course of which Moffat used abusive language. Ultimately the Managers of each team, Dudman and Humphries appeared, calmed the situation down and Moffat left.

The Stewards find that:-

Moffat pushed and placed his hand on Loasby's throat

Moffat took hold of Morgan's clothing as a result of which Morgan felt threatened.

Moffat used abusive language to Mrs Chilton.
