The Stewards heard evidence from the following persons:

Dominic Stott (Entrant and P/G of Gabriel Stilp). On-board footage from car 7 was viewed. Drivers Briefing Presentation and Drivers Briefing Notes were viewed.

The Stewards decision is:

The Appeal succeeds. The penalty of the addition of 5 seconds to the elapsed race time is rescinded and replaced with the penalty of a Formal Reprimand.

Reason(s) for this decision:

The Stewards find that the driver is guilty of failing to follow the instructions of an official in that the pit exit line was crossed several times contrary to the instructions given by the Clerk of the Course at the Drivers Briefing and as stipulated in the Briefing Notes.

However, the second sentence of Art. 13.6 of the Briefing Notes states "This will be monitored as per track limits and infringements may be penalised". Therefore, the Stewards consider it reasonable that Competitors should expect the same system of warnings as detailed in Q12.22.1.(b).

For this reason, the Stewards determine that the penalty of a Formal Reprimand is appropriate.
