The Stewards heard evidence from the following persons:

TOM INGRAM (DRIVER #1) AND HIS TEAM MANAGER, MARVIN HUMPHRIES. JAKE HILL (DRIVER #24) AND HIS TEAM MANAGER, CARL MITCHELL. EXTERNAL ITV FOOTAGE AND ON-BOARD FOOTAGE FROM #1 AND #24 WAS VIEWED BY ALL PARTIES.

The Stewards decision is:

TO UPHOLD THE DECISION OF THE CLERK OF THE COURSE.

Reason(s) for this decision:

THE BTCC EXPECTED STANDARDS DOCUMENT 2023, OVERTAKING, POINT 3, IS CLEAR THAT "ON THE EXIT OF A CORNER IF THE CAR ON THE OUTSIDE HAS AN OVERLAP ON THE CAR ON THE INSIDE THEN THE CAR ON THE INSIDE MUST LEAVE A MINIMUM OF ONE CAR WIDTH TO THE EDGE OF THE TRACK".

THE STEWARDS DETERMINE THAT #24 DID HAVE AN OVERLAP ON THE OUTSIDE OF #1 EXITING TURN 12 ON THE FINAL LAP. HOWEVER, THE DRIVER OF #1 DID NOT LEAVE THE REQUIRED MINIMUM ONE CAR WIDTH TO THE EDGE OF THE TRACK AND, AS A RESULT, DID GAIN AN ADVANTAGE (C2.3).

THE STEWARDS CONSIDER THAT THE PENALTY IMPOSED BY THE CLERK OF THE COURSE IS APPROPRIATE.
