Fact: Contact Trucks 12 & 86 at post 8 and post 10 . Contact Truck 12 and 68 (Video Evidence)

Offence: Alleged causing a collision Q.12.21.4

Decision: **No Further Action**

Reason: Limited video evidence available inconclusive Race Control video evidence therefore balance of proof relies on post Chiefs reports and driver interviews.


Incident 1 at post 10 circa 17:37 Hrs. Truck 12 into rear of truck 86. Post Chiefs report recommends no further follow up action required and does not give an opinion on the cause. On video review there was no contact. **No Further Action**

Incident 2 Post 8 circa 17:56 Hrs. Inconsistencies in evidence reported. Front page of report shows side to side contact Trucks 12 & 86, rear page shows contact between Trucks 12 & 83. Post Chiefs report recommends no further follow up action required and does not give an opinion on the cause. Drivers interviewed, conclusion racing incident due to track width. **No Further Action**

Incident 3 Truck 68 contact with rear of truck 86, on interview the failure of the rev limiter was cited as being the cause. Driver of 86 accepts this. As the Rev Limiter on truck 68 has now been corrected no scrutineering evidence is available. **No Further Action**
