Following investigations I find that you are guilty of contravening the following Motorsport UK Regulation:

Additional Information / Reasons for Decision (Refer to Motorsport UK C1.1.5 form appended to this form):

Rear end contact occurred between car 23 and 581. Video footage from car 23 was not available. From the video footage that was available the contact appeared avoidable. The driver agreed that a penalty should be applied based on the footage available.
