Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

**Q12.21.4** – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car.

Additional Information / Reasons for Decision:

On approach to the chicane, car 28 attempted to break, but found that the car did not slow as he expected. He pumped the pedal but made contact with car 88 and car 19. Car 28 finished the race. He appreciated the error made and that there was no intent in the incident.

On balance the penalty is limited to a formal reprimand and championship point penalty

Accordingly under Motorsport UK Regulation **G5.3.3**, I order that you:
