Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

Q12.21.4 – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car.

Additional Information / Reasons for Decision:

Contact between Car 44 and Car 50 at the Hairpin on Lap 1. Car 50 spun and Car 44 ran wide and continued.
 Both drivers interviewed with their team managers. Onboard footage reviewed from Car 44 & Car 50.
 This penalty carries a 4 point championship and category point deduction in accordance with championship regulation 4.2.3(a)
