Additional Information / Reasons for Decision / Evidence:

Coming through turn 8, avoidable contact between cars 69 and 20, causing 69 to leave the circuit and go into the gravel trap. Car 20 continued.

Driver and team manager of cars 20 and 69 interviewed.

On board footage from both cars and ITV footage viewed.
