Reason(s) for this decision:

NCR CH5, PART A, APP7, ART12.1.g STATES THAT ONE OF THE THE PRINCIPAL DUTIES OF TIMEKEEPERS IS TO ACT AS JUDGE OF FACT IN RESPECT OF TIMING MATTERS AT RACE AND SPEED EVENTS.

NCR CH5, PART A, APP4, ART2.17.f ALLOWS THE STEWARDS TO ACCEPT A CORRECTION MADE BY A JUDGE OF FACT.

THE STEWARDS, IN THE PRESENCE OF MR GILBY, SPOKE AT LENGTH BY TELEPHONE WITH MR DAFF (CHIEF TIMEKEEPER). MR DAFF CONFIRMED THAT THE PUBLISHED CLASSIFICATION OF ROUND 3 WAS CORRECT IN ACCORDANCE WITH THE DATA FROM THE TIMING EQUIPMENT AND THAT HE DID NOT WISH TO CORRECT HIS DECISION.

THEREFORE, THE STEWARDS MUST ACCEPT THE DECISION OF MR DAFF AS THE JUDGE OF FACT IN RESPECT OF TIMING MATTERS AT THIS RACE EVENT.
