THE STEWARDS RECEIVED THE PROTEST AND DETERMINE THAT THEY MAY HEAR IT AS IT WAS SUBMITTED CORRECTLY AND WITHIN THE APPLICABLE TIME LIMITS. THEY HEARD EVIDENCE FROM WAYNE EASON (ENTRANT), SAMI OJANEN (COMPETITOR #61). A SCRUTINEER'S NON-COMPLIANCE REPORT WHICH WAS RECEIVED SUBSEQUENT TO THE PROTEST BEING LODGED WAS ALSO CONSIDERED.

The Stewards decision is:

THE PROTEST IS UPHELD. COMPETITOR #61, SAMI OJANEN IS DISQUALIFIED FROM RACE 1.

Reason(s) for this decision:

A TECHNICAL JUDGEMENT OF FACT REPORT CONFIRMS THAT THE TYRES FROM TRUCK 61 WERE EXAMINED IN PARC FERME AFTER RACE 1 AND WERE FOUND TO BE MANUFACTURED BY GOODYEAR. THIS IS IN CONTRAVENTION OF BRITISH TRUCK RACING CHAMPIONSHIP REGULATION 5.13.1.

HAVING CONSIDERED THE MATTER, THE STEWARDS DO NOT CONSIDER THERE IS AN EXCEPTIONAL REASON WHY A PENALTY OF DISQUALIFICATION SHOULD NOT BE IMPOSED. NCR CH2, APP8, ART1.9 REFERS.
