Reason(s) for this decision:

THE WRITTEN NOTICE OF THE CLERK'S DECISION WAS FIRST DELIVERED TO THE COMPETITOR BY EMAIL FROM THE CLERK OF THE COURSE AT 19:13H ON 26 APRIL 2025. THIS WAS NOT DISPUTED BY THE ENTRANT. THE WRITTEN NOTICE OF APPEAL WAS RECEIVED BY THE CLERK OF THE COURSE AT 20:29H ON 26 APRIL 2025.

NCR CH2, APP4, ART1.5 STATES THAT NOTICE OF APPEAL MUST BE RECEIVED WITHIN 30 MINUTES OF THE FIRST NOTIFICATION OF THE DECISION TO THE COMPETITOR.

NCR CH2, APP4, ART1.6 ALLOWS THE STEWARDS AT THEIR ENTIRE DISCRETION TO EXTEND THE TIME LIMIT FOR THE DELIVERY OF A NOTICE OF APPEAL IN SUCH CIRCUMSTANCES AS THEY DEEM TO BE MERITED IN THE INTERESTS OF JUSTICE.

THE STEWARDS DECIDE THAT THE ENTRANT HAS NOT BEEN ABLE TO GIVE REASONABLE GROUNDS AS TO WHY THE APPEAL WAS SUBMITTED 46 MINUTES AFTER THE APPEAL TIME HAD ELAPSED. THEREFORE, THE APPEAL IS REJECTED.
