Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Car 18 made contact with car 95 at Turn 1 causing car 95 to leave the circuit. It was noted in the hearing that car 18 did not have a significant overlap on car 95 at the point of turn in.

Both drivers and team managers interviewed. On board footage from cars 18, 95 and 24 (evidence car) viewed.
