Additional Information / Reasons for Decision / Evidence:

Car 29 made contact with car 22 at Turn 2 causing both cars to leave the circuit and retire from the race. It was noted that car 22 had a significant overlap on car 29.

Both driver and team managers interviewed and on board footage from both cars viewed.
