Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

On Lap 1, Car 10 made contact with Car 99, causing Car 99 to Spin and subsequently there was a secondary contact with Car 10. Car 10 appeared to understeer after running across the kerbs. I find Car 10 predominantly to blame for the incident.

Onboard video footage from cars 10, 99 and 18 (Car behind) viewed, Drivers and Team Managers Interviewed.

This Penalty carries a 4 Championship Point and 4 category Point Deduction.
