(p) Safety Car Infringement (Ch.12, App.8, Art..2.6)

Additional Information / Reasons for Decision:

Marshal Report from Post 7.1 of car overtaking under SC and Yellow Light Signals.

Interviewed the driver of Car 3 and a team representative.

Reviewed onboard from Car 3.Video footage showed yellow /SC Panels and in car dash display were visible.

Car 3 overtook two other Cars 19 & 70 and then gave one place back. The place gained to Car 19 was not given back.

As this is the second similar incident this carries 2 times the standard Championship and Category Deductions, 6 point deductions from each championship.
