In accordance with Motorsport UK NCR Ch.2, App.10, Art.1.14 I am satisfied that there is a significant and relevant new element which was unavailable to the parties seeking the review at the time of the decision concerned and upon further investigation I find:

On board video shows the track limit reported by the Judge of Fact on lap 9 at turn 7 (McLeans) was not a breach of track limits. The car was on the curb and there was clearly a visible curb. The car was approximately 12 inch's away from the track limit sensor. Lap 8 and lap 10 was also checked.
Right of review upheld, fee returned. 5 second time penalty imposed in race 3 is rescinded.
You are advised of your right of appeal under NCR Ch.2, App.4.
