Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Avoidable contact between car 69 and 20 at turn 9, forcing both cars to leave the track and turn 2, causing car 20 to spin and continued.

On board video from car 69 viewed.

Driver and team managers from both cars interviewed.
