# 1.2 <u>PASSES:</u>

For those without permanent passes, e-tickets will be sent to you; those under the age of 13 are admitted free of charge. Please note, there are no vehicle passes for marshals at this event. Under no circumstances will marshals cars be permitted in the paddock at any time.

## 1.3 <u>SIGNING-ON:</u>

- a) All sign-on will need to be done electronically in advance of the Event. Officials will sign-on electronically using the link on the BARC website to the <u>Alpha Timing system</u>.
- b) There will be race day programmes produced for the event however entry lists will also be available on the BARC website.

#### 1.4 ENGINE/NOISE POLLUTION:

Engines must not be run before 08:30 (Sat) or 09:45 (Sun) or after 18:45 on both days. Noise checks will take place at the entrance to the assembly area for all support race categories.

#### 1.5 CIRCUIT ACCESS/PRACTICE AND QUALIFYING PROCEDURE

All Competitors are to follow the instructions issued via their Championship Coordinator and the Clerk of the Course.

**Support Races** – The Assembly Area is located by the Outer Paddock Scrutineering Bay. Cars will then follow the Safety Car through the vehicle tunnel, turning left on to the Cooper Straight and proceeding around Surtees and Clearways to the pit lane for qualifying and directly to the grid for races. All support buggies and personnel must proceed via the vehicle tunnels

and the roadway at the rear of the garages accessing the Pit Lane via the gate at the far end. All passes will be checked at this point prior to admission into the pit lane.

At the end of qualifying and races support competitors will take the chequered flag, complete a lap and then enter the pit lane, proceeding directly to Parc Fermé without stopping. Those required for ITV interviews will be stopped in the inner paddock and everyone else proceeds to the outer paddock.

## 1.6 LIVE SNATCH:

There is no "live snatch" at this event, however the Clerk of the Course may use vehicles to move stranded race cars while the safety car is in operation.

## 1.7 RACE STOPPAGE:

Any category which generates a race stoppage may be placed toward the end of the schedule subject to time being available.

#### 1.8 JUDICIAL PROCEDURES:

The judicial procedures for this Event will be in accordance with the NCR and all paperwork will be dealt with electronically. Any protest or appeal needs to be lodged with the Secretary of the Event or the Clerk of the Course using the email addresses provided.

## 1.9 RESULTS & NOTICE BOARD:

All time sheets, grids and results are deemed to be provisional until the conclusion of all judicial actions. Results will be available on the TSL website: <u>BTCC - Round 2 - TSL-Timing</u>

# 1.13 MARSHALS MATTERS:

Marshals may camp in the dedicated marshal's campsite in the Airfield. Marshals parking will be in the Lower Triangle across the road from the paddock entrance. Your tickets need to be shown on entering the circuit so please make them available.

All marshals must see the chief marshal between the times below to confirm their attendance. Check in will take place in the Outer Paddock Office adjacent to the vehicle tunnels at the times shown below.

#### **Special Notes:**

- a) For 2025 Motorsport UK has introduced the National Competition Rules to replace the General Regulations.
- b) You are reminded that Light Signals are installed at Brands Hatch and they must be the priority signal used at all marshals' posts rather than flags. It is imperative that the circuit light panels are operated quickly to signal to competitors as this will also trigger the in-car display to each driver. There will be set of flags on each post and these can be used in the case of a system failure or to supplement the light signals or to display additional signals should the panel be displaying a higher-grade signal. Signals for the Safety Car and for Stopping a session will be initiated and controlled by Race Control.
- c) Scrutineering will be in accordance with Motorsport UK NCR 12.4.4 which means that a minimum of 25% of the competitors in each championship will be selected for full physical scrutineering and all competitors will also completing a self-declaration form.
