Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Car 46 and 448 make contact.

Car 448 runs slightly deep but maintains control of the car. Car 46 goes into the corner and runs to the exit. Car 46 should have anticipated that car 448 would be slightly wider and given more room on the corner exit.

Video reviewed from cars 448 and 46 and both drivers interviewed
