Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Car 42 and 7 make contact at turn 1 lap 1.

Video from cars 42 and 7 reviewed. Drivers interviewed.

Car 42 gets a better start and approaches turn 1 slightly ahead - car 7 is still there. Car 42 turns into the apex of the corner but does not leave sufficient room for both cars. Car 42 makes contact with car 7.

Accordingly under Motorsport UK Regulation **NCR Ch.5, Pt A, App 5, Art 2.3 (c)**, I order that you:
