Following investigations, I find that you are guilty of contravening the following Motorsport UK NCR(s):

Ch.12 App.7 Art.1.8 (P) Contact with another Vehicle and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle.

**Brief Details:**

Contact was reported between cars 80, 71 and 777 between Turns 2 and 3.

Onboard footage from car 80 reviewed and drivers of cars 80, 71, 777 interviewed. Footage showed contact between front of car 80 and rear of car 71, with subsequent contact between front of car 71 and side of car 777. All cars continued.

Driver verbally informed of decision at 17:46hrs.
