The Stewards decision is:

THE APPEAL FAILS. THE STEWARDS UPHOLD THE DECISION OF THE CLERK OF THE COURSE.

Reason(s) for this decision:

THE STEWARDS DECIDE THAT APPROACHING TURN 1, CAR 11 WAS AHEAD OF CAR 59. CAR 11 HAD LEFT SUFFICIENT SPACE TO THE APEX PRIOR TO CONTACT BEING MADE BETWEEN THE FRONT LEFT OF CAR 59 AND THE REAR RIGHT OF CAR 11.

THE STEWARDS AGREE WITH THE CLERK OF THE COURSE THAT THE DRIVER OF CAR 59 WAS PREDOMINANTLY RESPONSIBLE FOR THE INCIDENT. THE PENALTY IMPOSED BY THE CLERK OF THE COURSE IS APPROPRIATE.
