THE STEWARDS CONSIDER THAT THE DRIVER OF CAR 29 HAD ALREADY COMMITTED TO THE CORNER BY MOVING SLIGHTLY TO THE RIGHT BEFORE CAR 12 HAD ANY OVERLAP AND THEREFORE AGREE WITH THE CLERK OF THE COURSE THAT THE DRIVER OF CAR 12 WAS RESPONSIBLE FOR CAUSING THE COLLISION.
