Additional Information / Reasons for Decision / Evidence Used:

Reports from the team manager of Car 44 of Car 5 not leaving a cars width on the start finish straight on Lap 18/19 (Vbox lap counter), prior to both cars making contact at Turn 1. Car 5 spun and continued, Car 44 continued.

Both drivers interviewed with their team managers and on-board footage reviewed from both cars.

Footage indicated that Car 5 carried out a series of manoeuvres in the latter part of lap 18 prior to the incident that potentially hindered Car 44.

Car 5 is considered to have carried out manoeuvres liable to hinder another driver.
