Additional Information / Reasons for Decision / Evidence:

Contact between Car 11 and 19 at T4 at 13:34. Driver of car 11 and Signed on Guardian (Martin Broadhurst) and driver of car 19 interviewed. Video from Car 11 viewed.
Car 11 lost control under braking and half spun, making contact with car 19. Both continued, with car 11 entering the pits for repairs.
