Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

**Ch.12, App. 7, Art. 1.8** – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Onboard footage evidence showed side to side contact between Car 27 and Car 70 and Lodge Corner on the last lap. Both cars continued. The drivers of Cars 27 & 70 interviewed with their team managers. Onboard footage reviewed from Cars 27, 70 & 99, Car 99 was behind the incident. Car 27 is considered to have caused a collision.
