The Stewards heard evidence from the following persons:

Oliver Meadows, Competitor #88; Barry Horne, Team Manager Team Parker Racing; Matthew Kyle-Henney Competitor #25; Edward Marks Team Manager Clean Racing On Board video evidence from Competitor #88 and Competitor #25

The Stewards decision is:

The Appeal Succeeds and the Stewards determine that Competitor #25, Matthew Kyle-Henney gained an unfair advantage (whether inadvertently or not) making contact with the rear of Competitor #88 at the exit to the Hairpin on the final lap. The Stewards also determine that Competitor #25 is penalised by the addition of One Second to your elapsed race time in Race 3 (Porsche Sprint Challenge GB). No penalty points are recorded on your licence as a result of this decision.

Reason(s) for this decision:

The Stewards consider that the contact between Competitor #25 and Competitor #88 on the exit from the Hairpin on the last lap was sufficient to unsettle the balance of car #88 and #25 gained an advantage whether inadvertently or not. The Stewards penalise competitor #25 by the addition of one second to his elapsed race time (NCR Ch2.AnnexA,Art1.3).
