Notes to the proxy form

1. As a member of the Company you are entitled to appoint a proxy to exercise all or any of your rights. You can only appoint a proxy using the procedures set out in these notes.

2. To appoint as your proxy a person other than the Chairman of the meeting, insert his or her full name in the box. If you sign and return this proxy form with no name inserted in the box, the Chairman of the meeting will be deemed to be your proxy and your vote or abstention will be cast in line with that of the Chairman. Where you appoint as your proxy someone other than the Chairman, you are responsible for ensuring that he or she is aware of your voting intentions. If you wish your proxy to make any comments on your behalf, you will need to appoint someone other than the Chairman and give that person the relevant instructions directly.

3. To direct your proxy how to vote on the resolutions mark the appropriate box with an "X". If no voting indication is given, your proxy will vote or abstain from voting at his or her discretion. Your proxy will vote (or abstain from voting) as he or she thinks fit in relation to any other matter which is put before the meeting.

6. To change your proxy instructions simply submit a new proxy appointment in accordance with note 5. Note that the cut-off time for receipt of proxy appointments (see above) also applies in relation to amended instructions; any amended proxy appointment received after the relevant cut-off time will be disregarded. If you submit more than one valid proxy appointment, the appointment received last before the latest time for the receipt of proxies will take precedence.
