Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

**Ch.12, App. 7, Art. 1.8** – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Left front into right rear contact between Car 18 and Car 62 at Turn 11 reported via Marshal Report and observed on Circuit CCTV in Race Control. Both cars continued.  
Interviewed both drivers and reviewed on-board footage from Cars 18, 62 & 144 which was behind the incident.  
Car 18 is considered to have caused a collision.
