Following investigations, I find that you are guilty of contravening the following Championship Regulation(s):

Britcar Reg. 5.1.5 and TCR 5.11.1 Technical Non-Compliance - Turbo Pressure Overboost

## **Brief Details:**

The Clerk of the Course has received a Non-Compliance Report that Car 25 does not comply with Britcar Regulations 5.1.5 and TCR-UK Art. 5.11.1 The Non-Compliance report is signed by both the Chief Scrutineer and an Eligibility Scrutineer and is therefore considered to be "Judge of Fact" under NCR Ch. 2 App. 8 Art. 1.8

Having held a hearing, I find that there are mitigating circumstances in that:

- Something has happened with the electronics of the car at the event, in that a sealed, homologated part that the competitor has no access to has started generating a number of errors.
- The multiple errors (5) codes within the vehicle system, results in a minor overboost being recorded by the data collection systems in the vehicle.
- During the parts of the event the overboost/error codes were being recorded, Car 25 lap times appear longer compared to other competitors in class.

Following a review of the criteria for "exceptional reasons", I find that while the mitigating reasons are substantial they fall short of the exceptional criteria.

Therefore, under NCR Ch. 2 App. 8 Art. 1.9, I am required to disqualify Car 25 from the results of Race 5 (The second Britcar race).

The competitor is reminded that under of his right of appeal under NCR Ch. 2 App. 8 Art. 1.16
