Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

**Ch.12, App. 7, Art. 1.8** – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Car 56 made front to rear contact with car 22 at turn 8. Evidence was given in the judicial hearing that there was an issue with the brakes of car 56. Data was reviewed with the MINI CHALLENGE Technical Director and there was a lower brake pressure leading to the contact. As a result there is mitigating circumstances.

Both drivers and team entrants interviewed.

On board footage from car 56 and ITV footage viewed.
