Judicial hearing carried out at Donington Park 28/08/2025 due to time constraints at Croft.

Car 38 gained an unfair advantage on car 11 at Sunny In, it was deemed car 38 did not leave sufficient space for car 11.

Drivers and team managers of cars 11 & 38 interviewed. On board footage from cars 11 & 38 viewed.

This decision was given verbally and in writing and drivers were advised of their right of appeal. Any appeal will be brought before the Stewards at Donington Park 30/08/2025.
