Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

**Ch.12, App. 7, Art. 1.8** – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Judicial hearing carried out at Donington Park 29/08/2025 due to time constraints at Croft.

Car 4 made contact with car 69 at the Hairpin. It was noted in the judicial hearing that car 4 did not have a sufficient overlap on car 69 at the point of turn in.

Both drivers and team managers interviewed and on board footage from cars 4 & 69 viewed.

This decision was given verbally and in writing and drivers were advised of their right of appeal. Any appeal will be brought before the Stewards at Donington Park 30/08/2025.
