Additional Information / Reasons for Decision / Evidence:

Judicial hearing carried out at Donington Park 28/08/2025 due to time constraints at Croft.

Car 88 made contact with car 11 into the Hairpin which caused contact with car 59 causing car 59 to leave the circuit and retire from the race.

Drivers and team managers of cars 11, 59 & 88 interviewed. On board footage from cars 11, 59 & 88 viewed.

This decision was given verbally and in writing and drivers were advised of their right of appeal. Any appeal will be brought before the Stewards at Donington Park 30/08/2025.
